

Addendum to the EU model agreement for personal data transfer to a non-EEA controller

Data Importer

Data Importer has read and accepted the Rights and Responsibilities (in which it is referred to as **Operator**) that constitute the contractual agreement for conducting business with Data exporter.

Data Importer agrees to adhere to the data protection laws of the Netherlands, the country where Data Exporter is established. Data protection laws in the Netherlands are fully congruent with the EU General Data Protection Regulation (GDPR).

In the event of a dispute between the Data Importer and the Data Exporter concerning any alleged breach of any provision of these clauses, such dispute shall be finally settled under the rules of arbitration of the International Chamber of Commerce by one or more arbitrators appointed in accordance with the said rules. The place of arbitration shall be Utrecht, the Netherlands.

In the event of termination of these clauses, the Data Importer must return all personal data and all copies of the personal data subject to these clauses to the Data Exporter forthwith or, at the Data Exporter's choice, will destroy all copies of the same and certify to the Data Exporter that it has done so, unless the data importer is prevented by its national law or local regulator from destroying or returning all or part of such data, in which event the data will be kept confidential and will not be actively processed for any purpose.

ANNEX B – DESCRIPTION OF THE TRANSFER

Data subjects

The personal data transferred concern the following categories of data subjects:

- Users of the Seats2meet.com platform
- Contact details of employees working at client organizations

Purposes of the transfer(s)

The transfer is made for the following purposes:

- To allow the Data Importer and Data Exporter to conduct business, as defined in the Rights & Responsibilities agreement between both parties.

Categories of data

The personal data transferred concern the following categories of data:

- Basic identification (First name, last name, address, profile image, email address)
- Collaboration (Biography, knowledge tags, network matches)
- Presence (check-in location and status of user)
- Booking (reservations and passed transactions)

Recipients

The personal data transferred may be disclosed only to the following recipients or categories of recipients:

- Users of the Seats2meet.com platform that are employed by Data Importer.

Sensitive data (if appropriate)

The personal data transferred concern the following categories of sensitive data:
